AMAC members rose to the occasion in quick fashion by responding to an after-hours *call-to-action* urging the Senate to support S. 4293, the Pharmacy Benefit Manager Transparency Act, and move it out of committee. AMAC advocates sent nearly **10,000** messages to the Senate within **12 hours** and helped get the bill out of committee!

The bill, which AMAC supports, would evaluate the anticompetitive practices used by Pharmacy Benefit Managers (PBMs) and crack down on their use by improving transparency.

We'll keep an eye out for the floor vote on this bill...



UPDATE:

Earlier this spring, Colorado AMAC members responded to a *call-to-action* and helped to get a bill (HB 1285) through the state legislature that would prohibit hospitals from pursuing medical debt from patients if they were not in compliance with federal hospital transparency laws.

We're happy to report that the bill was signed into law by Colorado's governor on June 8.

Way to go, Colorado AMAC members!

AMAC members in *New Hampshire* have responded to *calls-to-action* to become more involved in the forthcoming September primary and November mid-term elections.

So far, **78 AMAC members** have committed to becoming election inspectors in that state.
