Social Security Myth of the Month:

Is Social Security Going Bankrupt?

Put simply, the answer to the question is a solid “no.” By design, Social Security cannot run completely out of money as long as there is a workforce paying that ubiquitous payroll tax. But let's quickly recognize that there are indeed long-term problems regarding the program's funding. As of last year, the program is operating in a deficit mode using reserves held in its trust fund to make promised benefit payments. These reserves, a resource that had reached nearly \$3 trillion just a few years ago, will enable Social Security to pay promised benefits fully for about another decade, based on the most recent projections from the program's Trustees.

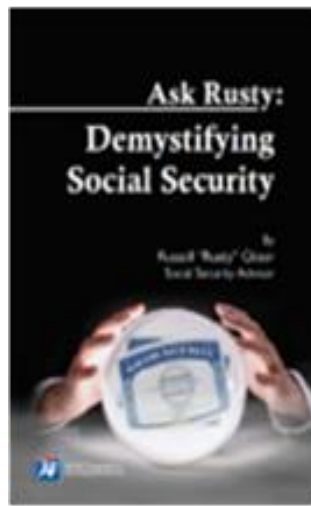

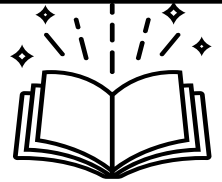

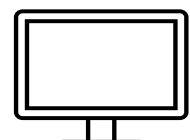
